## Supervisor's Report

In December, Libertyville Township gave out food to 403 households, which consisted of 928 individuals. The list of food and/or monetary donors was shared.

An update on the amount of financial assistance provided in 2020 was shared:

- \$25,331 from the Community Emergency Assistance Fund
- \$17,575.00 from the Emergency Assistance Fund We also processed
- \$24,153 in rental assistance from the CHRP funds in partnership with Lake County and the federal government

The Emergency Assistance helped 14 households totaling 60 individuals. The Community Emergency Assistance assisted 27 households totaling 85 individuals.
