Highway Commissioner Neal reported the road resurfacing is going well. The Oak Spring Lane Stormwater Management Bypass project went out for bid. The bid opening will be held Friday, July 22, 2022.

Supervisor's Report

In June, food was provided to 326 households, which consisted of 684 individuals. Donations were received from First Presbyterian Church of Libertyville, Libertyville Sunrise Rotary, Dairy Dream of Libertyville, Lake County Bar Association, Ms. Saia's 2nd Grade Class at Oak Grove School, and private individuals.

As of July 19, 2022, the Township has provided fifty-three applications for assistance. Of those, twenty have submitted completed applications. Twelve households have been approved for Emergency Assistance with a total allocation of \$10,093.45. Fifteen households have been approved for Community Emergency Assistance with a total allocation of \$13,048.37. The combined total of financial assistance provided is \$23,141.82.

There were two volunteers at the July 9th open space workday. The next volunteer workday is Saturday, August 13th at Oak Openings.

OLD BUSINESS

The Township received noticed that we were approved for a \$10,000 ComEd's Green Region grant.

Land & Water Resources provided the Township a check for \$51,150.00 for the final Atkinson Road Wetland Mitigation credit sold.

The Rt. 45 Restoration Project is moving forward. A proposal from Gewalt Hamilton will be presented to the Board for approval as part of the DCEO grant application process.

NEW BUSINESS

Trustee August asked if the County has a proposal for the former Winchester Property. Supervisor O'Connor said the Township is not aware of any plans.
