

Open Space 2015 Annual Report

Libertyville Township Open Space District owns over 1,500 acres of Open Space. The Township has 2 full time employees who are responsible for all maintenance and restoration efforts. In addition to the staff, Libertyville Township has a long standing established partnership with Conserve Lake County. Conserve Lake County links the Township to grant opportunities, coordinates volunteer work days and provides professional assistance in a variety of areas.

Special Projects

Bull Creek Trail Construction Project

Libertyville Township began construction of the Rt. 137 Bull Creek Trail Connector Project. The trail connection provides a critical link to the regional trail system. The project is a partnership between the Township, the Village of Libertyville and Commonwealth Edison as portions of the trail will be constructed on each of our properties. Pearson, Brown & Associates, Inc. provided engineering services and Team REIL, Inc. was awarded the construction contract. It is anticipated the project will be completed by June 2016. In addition, the Lake County Audubon Society has received several grants on behalf of the Township to assist in the restoration efforts and improve bird habitat.

Canterbury Herbicide Project

In spring and fall of 2015, herbicide was applied to 80 acres at Canterbury to control reed canary grass and phragmites. A follow-up application is scheduled for spring 2016.

Casev Road Land Use Plan

The Township has started the implementation phase of the Casey Road Land Use Plan with technical support provided by Conserve Lake County. Activities have included: wetland delineation, applying and securing grant funds, the exploration of mitigation bank opportunities, and the retiring of one farm field.

Partnership with Mundelein Park and Recreation District (MPRD) on Prescribed Burns

Libertyville Township entered into an Intergovernmental Agreement with the Mundelein Park and Recreation District to assist in the development of the District's burn project and shared resources. In spring of 2015, MPRD conducted their first prescribed burn with the assistance of Township staff. In turn, MPRD provided assistance on two Township burns.

Snake Hibernaculum

Two students from the Prairie Crossing Charter School installed a snake hibernaculum at the Canterbury property with assistance from Dr. Michael Corn, Libertyville Township Open Space staff and Libertyville Township Highway Department staff.

Volunteer Herbicide Class for Open Space Volunteers

On January 10, 2015, Libertyville Township and Conserve Lake County partnered to provide an herbicide training class to 14 volunteers interested obtaining a volunteer herbicide license. The license allows open space volunteers to participate in herbicide activities under the supervision of Township staff and Conserve Lake County's Director of Volunteers.

Volunteer Work Days

Volunteer Work Days are held the second Saturday of each month from 9:00 to Noon at Oak Openings or Liberty Prairie. The Work Days are a coordinated effort between the Township and Conserve Lake County. In 2015, 9 work days were held at Oak Openings and 3 were held at Liberty Prairie. On average, 5 volunteers attended per work day. Activities included applying herbicide, clearing invasive species, collecting seed, pulling garlic mustard and/or clover and participating in prescribed burns.

Conservation Easement Baseline Data

In 2010, Libertyville Township began documenting baselines and conducting annual monitoring for the conservation easements it holds on 6 privately owned properties. The work is being carried out with the assistance of Conserve Lake County. This provides an opportunity for the Township to partner with the landowners to ensure the integrity of each conservation easement is maintained. In 2015, the Township completed the following monitoring activities:

- Brennan Easement During the construction, the property was monitored on a weekly basis to ensure no impacts to easement occurred. On April 24, 2015, the Township completed the annual easement monitoring on the entire site.
- Bott Easement Completed annual easement monitoring on September 2, 2015.
- Getz Easement This easement covers three separate properties. Separate baselines have been created for each property. In 2015, all 3 properties were purchased by a single owner.
 - o Completed annual easement monitoring for Getz 1 on September 2, 2015.
 - o Completed annual easement monitoring for Getz 2 on September 2, 2015.
 - o Completed annual easement monitoring for Getz 3 on September 2, 2015.
- Maxey Easement Completed annual easement monitoring on April 28, 2015.
- Bleck Easement In 2015, the Township met with family members of the property owner of the
 conservation easement to discuss the Township's desire to begin monitoring of the conservation
 easement.

Site Specific Activities

In 2015, the Libertyville Township Open Space District applied approximately 113.07 gallons of herbicide, planted 11 trees, removed 97 dead or dying trees, spread approximately 946 pounds of seed covering 22.8 acres, cleared .85 acres of invasive woody species, planted 71 plants, and conducted prescribed burns on 12.95 acres. These numbers will fluctuate based on each property's needs over time.

Atkinson

Fall:

- Seed collection
- Planting native species
- Herbiciding invasive plants
- Trail maintenance and repairs
- Clean and inspect water control structures for wetlands open for fall
- Burning is done on a rotating basis during the month of November. Sites are prioritized and are burned in accordance with the prescribed burn management plan
- Weekly activities: mowing, weed whacking, raking of baseball diamonds
- Monthly Volunteer Work Day
- Open Space employees assist with the maintenance of Township grounds
- Assist with food pantry activities as needed
