

Open Space 2016 Annual Report

Libertyville Township Open Space District owns over 1,500 acres of Open Space. The Township has 2 full time employees who are responsible for all maintenance and restoration efforts. In addition to the staff, Libertyville Township has a long standing established partnership with Conserve Lake County. Conserve Lake County links the Township to grant opportunities, coordinates volunteer work days and provides professional assistance in a variety of areas.

Special Projects

Atkinson Tree Removal Project

Libertyville Township engaged Advanced Tree Care to remove 75 hazardous trees from the Township's Atkinson Road Property. The trees presented a hazard because of their proximity to homes and the trail.

Bull Creek Trail Construction Project

Libertyville Township completed construction of the Rt. 137 Bull Creek Trail Connector Project. The trail connection provides a critical link to the regional trail system. The project was a partnership between the Township, the Village of Libertyville and Commonwealth Edison as portions of the trail will be constructed on each of our properties. Pearson, Brown & Associates, Inc. provided engineering services and Team REIL, Inc. was awarded the construction contract. The trail was completed in June 2016 with a Trail Opening Celebration held on July 21, 2016. In addition, the Lake County Audubon Society received several grants on behalf of the Township to assist in the restoration efforts and improve bird habitat.

Bluebird Nest Boxes Project

A Libertyville High School Eagle Scout installed bluebird nest boxes at Canterbury for his Eagle Scout project. A total of 6 bluebird next boxes were installed with assistance provided by Libertyville Township Opens Space staff.

Casey Road Farmland Restoration Project

The Township has started the implementation phase of the Casey Road Land Use Plan with technical support provided by Conserve Lake County. Activities have included: water & soil sampling, surveying & legal descriptions, baseline photos, hedgerow removal, drain tile removal, seed purchase & planting of oak trees. The hedgerow removal has created nearly 70 uninterrupted acres of habitat.

Red-tailed Hawk Nesting Platform Project

A student from the Prairie Crossing Charter School installed a Red-Tailed Hawk nesting platform at the Canterbury property with assistance from Libertyville Township Open Space staff.

River Road Fire Training

In 2016, Libertyville Township acquired a parcel with a home on the property as part of a land swap transaction. The Township contacted Waukegan Fire Department offered the site as a location for a burn training. The joint project allowed the Township to reduce the cost in the demolition of the home and provided a unique fire training opportunity for the Waukegan, Libertyville and Gurnee Fire Departments.

Volunteer Herbicide Class for Open Space Volunteers

On January 9, 2016, Libertyville Township and Conserve Lake County partnered to provide an herbicide training class to 19 volunteers interested obtaining a volunteer herbicide license. The license allows open space volunteers to participate in herbicide activities under the supervision of Township staff and Conserve Lake County's Director of Volunteers.

Volunteer Work Days

A majority of the Volunteer Work Days are held the second Saturday of each month from 9:00 to Noon at Oak Openings or Liberty Prairie. Those work days are a coordinated effort between the Township and Conserve Lake County. In addition, the work days were held on other township properties. In 2016, the Township held 17 volunteer work days with participation from 104 individual volunteers. Activities included applying herbicide, clearing invasive species, collecting seed, pulling garlic mustard and/or clover and participating in prescribed burns.

Conservation Easement Baseline Data

In 2010, Libertyville Township began documenting baselines and conducting annual monitoring for the conservation easements it holds on 6 privately owned properties. The work is being carried out with the assistance of Conserve Lake County. This provides an opportunity for the Township to partner with the landowners to ensure the integrity of each conservation easement is maintained. In 2016, the Township completed the following monitoring activities:

- Brennan Easement Completed annual easement monitoring on May 6, 2016.
- Bott Easement Completed annual easement monitoring on September 12, 2016.
- Getz Easement This easement covers three separate properties. Separate baselines have been created for each property. In 2016, all 3 properties were purchased by a single owner.
 - o Completed annual easement monitoring for Getz 1 on September 12, 2016.
 - o Completed annual easement monitoring for Getz 2 on September 12, 2016.
 - o Completed annual easement monitoring for Getz 3 on September 12, 2016.
- Maxey Easement Completed annual easement monitoring on May 6, 2016.
- Bleck Easement In 2016, the Township met with family members of the property owner of the
 conservation easement to discuss the Township's desire to begin monitoring of the conservation
 easement.

Site Specific Activities

In 2016, the Libertyville Township Open Space District applied approximately 2,694.5 gallons of herbicide, planted 284 trees & shrubs, removed 23 dead or dying trees, spread approximately 673 pounds of seed, cleared 5 acres of invasive trees, planted 818 plugs, 30 brush piles burned and conducted prescribed burns on 113.1 acres. These numbers will fluctuate based on each property's needs over time.

Atkinson

- Land and Water Resources and Applied Ecological Services continued restoration efforts on mitigation bank

- Site of 9 volunteer work days (8 Saturday & 1 mid-week) activities included applying herbicide, spreading 10 pounds of seed to 1 acre, removing invasive species and collecting 20 lbs. of seed
