

Open Space 2017 Annual Report

Libertyville Township Open Space District owns over 1,500 acres of Open Space. The Township now has 3 full time employees who are responsible for all maintenance and restoration efforts. In addition to the staff, Libertyville Township has a long standing established partnership with Conserve Lake County that has now merged with Openlands. They have linked the Township to grant opportunities, coordinated volunteer work days and provided professional assistance in a variety of areas.

In 2017, the Township applied 2,132.53 gallons of herbicide, 7,610.3 pounds of native seed was sowed, 410 acres mowed, 75 trees were removed, 80 acres underwent a prescribed burn, 154 native trees were planted, 6.5 acres were cleared of invasive species, 18 brush piles were burned, 19 volunteer work days were held and 73 individuals volunteered.

Special Projects

Bluebird Nest Boxes Project

A Libertyville High School Eagle Scout installed bluebird nest boxes at Canterbury for his Eagle Scout project. A total of 6 bluebird next boxes were installed with assistance provided by Libertyville Township Opens Space staff. In 2017, the signage for the project was installed.

Casey Road Farmland Restoration Project

The restoration of the 303 acres of agriculture land continued with technical support provided by Openlands. Legal descriptions were created and boundaries were marked for 195 acres of the site. Year 2 of Phase 1 activities included spreading approximately 6,000 lbs. of native seed, water sampling, cleared approximately 5 acres of invasive species, planted 125 native trees, and additional acreage added as buffer to the Illinois Nature Preserve. The Township received \$201,450 in grant funding for the restoration efforts. In 2017, the Township was notified it was awarded up to \$120,000 for the Illinois EPA's 319 Clean Water Act Grant.

Equipment Auction and Purchase

The Township auctioned off several pieces of aging equipment. The revenue generated offset the cost of the purchase of a new Ford F-550 and ASV RT - 120 Forestry.

Morton Arboretum Tree Grant

The Township was award \$11,450 to plant 125 trees of 8 different species at our Casey South property. This project was part of a larger restoration effort. The planting was held on October 21 and 28, 2017. It was supported by a strong community effort that provided 110 hours of volunteer support.

River Road Fire Training

In 2016, Libertyville Township acquired a parcel with a home on the property as part of a land swap transaction. The Township contacted Waukegan Fire Department offered the site as a location for a burn training. The joint project allowed the Township to reduce the cost in the demolition of the home and provided a unique fire training opportunity for the Waukegan, Libertyville and Gurnee Fire Departments. In 2017, the Township completed restoration efforts by removing the structures not completely demolished by the fire: the garage, house basement, remaining home structure and driveway. Site

restoration activities included: applying 9.5 gallons of herbicide, planting 3 trees and spreading 78 lbs. of native seed to 5 acres.

Township Open Space 5 K Fun Run

The Township Clerk organized a 5K Fun Run that was held at the Canterbury Property. There were a total of 72 participants and 9 sponsors. The race raised \$820 after expenses to benefit the Open Space District.

Volunteer Herbicide Class for Open Space Volunteers

On January 14, 2017, Libertyville Township and Openlands partnered to provide an herbicide training class to 7 volunteers interested obtaining a volunteer herbicide license. The license allows open space volunteers to participate in herbicide activities under the supervision of Township staff and Conserve Lake County's Director of Volunteers.

Volunteer Work Days

A majority of the Volunteer Work Days are held the second Saturday of each month from 9:00 to Noon at are typically held at Oak Openings or Liberty Prairie. This year, work days were held at the Rt. 137 and Old School properties. Those work days are a coordinated effort between the Township and Openlands. In 2017, the Township held 19 volunteer work days with participation from 73 individual volunteers. Activities included applying herbicide, clearing invasive species, collecting seed, pulling garlic mustard and/or clover and participating in prescribed burns.

Conservation Easement Baseline Data

In 2010, Libertyville Township began documenting baselines and conducting annual monitoring for the conservation easements it holds on 6 privately owned properties. The work is being carried out with the assistance of Openlands. This provides an opportunity for the Township to partner with the landowners to ensure the integrity of each conservation easement is maintained. In 2017, the Township completed the following monitoring activities:

- Brennan Easement Completed annual easement monitoring on September 11, 2017.
- Bott Easement Completed annual easement monitoring on May 8, 2017.
- Getz Easement This easement covers three separate properties. Separate baselines have been created for each property. In 2016, all 3 properties were purchased by a single owner.
 - o Completed annual easement monitoring for Getz 1 on May 8, 2017.
 - o Completed annual easement monitoring for Getz 2 on May 8, 2017.
 - o Completed annual easement monitoring for Getz 3 on May 8, 2017.
- Maxey Easement Completed annual easement monitoring on September 11, 2017.
- Bleck Easement In 2017, the Bleck property was sold to a new property owner. The Township met with the new the property owners to discuss the Township's desire to begin monitoring of the conservation easement. It is anticipated the baseline will be created in 2018.

Site Specific Activities

In 2017, the Libertyville Township Open Space District applied approximately 2,132.53 gallons of herbicide, planted 154 trees, removed 75 dead or dying trees, spread approximately 7,610.3 pounds of seed, cleared 6.8 acres of invasive species, 18 brush piles burned and conducted prescribed burns on 80 acres. These numbers will fluctuate based on each property's needs over time.

Atkinson
