Highway Commissioner's Report

Highway Commissioner Neal said there were 4 more snow events since the last meeting. As the snow melts, the potholes will be repaired.

In several weeks, the bid opening for the Knollwood Drainage and Resurfacing Project will be held. The Road District will be partnering with Lake Bluff and Lake Forest on the project.

Trustee Dohrn asked Highway Commissioner Neal to explain the Law Enforcement line item. Highway Commissioner Neal said it is for speed traffic enforcement on Casey Road and Rockland Road. He stated it has been very effective and appreciated by residents.

Trustees' Report

Trustee August and Trustee Kovatch commented the stormwater issues have been minimal in the Township. They expressed their gratitude for the proactive measures the Road District has taken to prevent flooding.

Supervisor's Report

The Libertyville Township Soccer Complex held their rescheduled Annual Meeting on Tuesday, February 23rd. Supervisor O'Connor attended the meeting. She reported the Soccer Complex's day-to-day operations of the complex are handled by the Greater Libertyville Soccer Association (GLSA). LTSC is working on a 10–20-year plan for the complex.

Highway Commissioner Neal did not exceed the overall appropriation, so the Board is not required to amended budget. There was no further discussion.
