# 2014-15 LIBERTYVILLE TOWNSHIP TAX LEVY PRESENTATION AND DISCUSSION

Pam Milroy, Township Financial Director prepared a worksheet which outlines the Tax Levy for the Township and the Road District. Ms. Milroy explained the Township is half way through the current fiscal year so the end of the year balances are a projection. The figures are a close estimate so to avoid any tax objections.

Supervisor O'Connor said one of the major projects planned for next year and possibly the following year is the construction of trail on the Township's Rt. 137 property.

Trustee Nield asked about additional costs that may be incurred by our Web provider. Supervisor O'Connor said she would look into it. Supervisor O'Connor said at the next meeting she will go over each line item in the draft budget. The Levy must be filed by the last Tuesday in December. Discussion ensued.

## 2014-15 LIBERTYVILLE TOWNSHP TAX LEVY PRESENTATION – DISCUSSION

Ms. Milroy explained the Highway Department's tax cap is 5%. Since the cost of maintaining roads is expensive, the Highway Department is asking 4.99% increase over last year's levy. Ms. Milroy also explained that 44% of the Levy for the Highway Department goes to the Villages in the Township. Discussion ensued.

### CASPER/ARCHDIOCESE PROPERTY

The Township received one bid for the Casper/Archdiocese Parcel. Per the Board's direction, the minimum bid was set at \$70.00 per acre. Haraden Farms & Stables, Inc. submitted a bid in the amount of \$101.00 per acre.

At the next meeting the board will be asked to approve the awarding of the license agreement to Haraden Farms & Stables, Inc.

#### **OLD BUSINESS**

Supervisor O'Connor said the Township received the money from the Public Assistance Grant. It was for a total of \$8,056.52. Of that \$995.53 will go into the Town Fund and the balance of \$7060.99 will go into the Road District.

The St. Mary's Road trail project is moving along. They have made considerable progress this week.

The Waukegan Park District has started the 2<sup>nd</sup> phase of the River Road Trail. It is anticipated the actual construction will begin October 11<sup>th</sup>.

The Illinois Municipal Retirement Fund audit is scheduled for this coming Tuesday, October 15<sup>th</sup> at 10:30.

Lake County Stormwater Management Commission has provided their review of the remediation plans by Hey & Associates for the Bull Creek Headwaters project. Supervisor O'Connor will be meeting next week to discuss their review with Hey & Associates and Lake County Stormwater Management Commission.

### **NEW BUSINESS**

Supervisor O'Connor met with Libertyville's Fire Chief Carani and toured the trail through Oak Openings and Liberty Prairie. The Libertyville Fire Department will be conducting some training on the property next week.

Trustee Nield said he would like the Board to consider taking some of the regular board meetings off site. He said if the people won't come to us for the meetings we will "take the meetings to the people". Trustee O'Connor had suggested this before and Trustee Nield liked the idea.
