Highway Commissioner Neal said the Rockland Road Project is complete. He is working to have the Rockland Road speed limit reduced to 25 from the bridge to St. Mary's Road.

Trustees' Report

Trustee Nield stated he is moving out of the Township and will resign his position effective 12.31.2020.

Supervisor's Report

In October, the Township provided food to 322 households which consisted of 756 individuals. The community has been incredibly generous with donations to the Food Pantry and Community Emergency fund.

Supervisor O'Connor informed the Board that work schedule adjustments have been made in accordance with Governor Pritzker's Tier III Mitigation.

APPROVAL TO AWARD RT 137 WETLAND RESTORATION SEED ORDER-SHOOTING STAR NATIVE SEED - DISCUSSION & VOTE:

Supervisor O'Connor said the Township received 4 quotes for the seed order ranging in price from \$14,119.84 - \$24,372. Some of the quotes included shipping, others did not.
