Since the "Shelter in Place" order, the Libertyville Township Food Pantry has seen a significant rise in food pantry applicants. The community has been extremely generous. The Township office is closed to the public, but the Supervisor and Alex Rodriguez, the Township Building and Grounds Manager, have been present full time. The remaining Township staff and elected officials have been rotating shifts and working remotely to meet the needs of the Libertyville Township residents. Masks and gloves were provided by the Libertyville Fire Department. All are adhering to social distancing, hand washing and sanitizing guidelines.

Supervisor O'Connor applied for a grant from United Way of Lake County which would aid specifically related to the Covid-19 disaster.
