Highway Commissioner Neal said the scope of the resurfacing and patching projects are being finalized.

Trustees' Report

Trustee Nield asked Highway Commissioner Neal how the Rockland Road project is progressing. Highway Commissioner Neal said Phase I Engineering is going well; the whole project should be completed by 2018.

Supervisor's Report

- There were general announcements about the Food Pantry.
- Supervisor O'Connor attended Conserve Lake County's Annual Meeting. Conserve Lake County highlighted the partnership with the Township.
- Supervisor O'Connor said there was an error in calculations for the Personal Property Replacement Tax which resulted in an over payment to the Township in the amount of \$10,834.87 and \$6,861.29 for the Road & Bridge Fund. The Township has not received any information from the State regarding the refund process.

APPROVAL OF PROPOSAL TO ENGAGE HEY & ASSOCIATES FOR CONSULTING SERVICES FOR HYDROLOGIC RESTORATION AT THE CASEY ROAD NORTH AND SOUTH SITES – DISCUSSION & VOTE

Vince Mosca, Vice President and Senior Ecologist, and Kevin Kleinjan, Engineer, for Hey and Associates explained the technical assistance Hey & Associates will provide for the drain tile disablement for the Casey Road north and south sites. After some discussion, a motion by Trustee Falbe, seconded by Trustee Nield to engage Hey & Associates for consulting services for hydrologic restoration at Casey Road North & South. On roll call vote: Trustee O'Connor, aye, Trustee Falbe, aye, Trustee Nield, aye, Supervisor O'Connor, aye. Motion carried.

APPROVAL OF CONSULTING SERVICES WITH CONSERVE LAKE COUNTY-DISCUSSION AND VOTE:

Supervisor O'Connor said the Conserve Lake County contract is 2 years and approximately 40 hours of service per month. The fee is \$2,500 per month the first year and \$3,000 per month the second year. Trustee Falbe recused himself from the vote as he serves on the Board for Conserve Lake County.
