CITIZENS' COMMENTS

Al Devon, 15570 W Rockland Road, questioned the procedure for the final decision on the Rockland Road project. What phase is to be implemented and why only the Highway Commissioner makes the final decision. Supervisor O'Connor explained the Highway Commissioner has complete autonomy, does not need Board approval per the Illinois Statute. The board approves the Road District's levy, budget and expenditures. Mr. Devon asked what can be done to change this. Supervisor O'Connor recommended that he contact his state legislators.

Highway Commissioner's Report – Absent – Supervisor O'Connor communicated to the Board in the Highway Commissioner's absence.

- The 2017 Road Resurfacing/Patching bid opening was held on Thursday, June 15 at 9:00 a.m. Peter Baker was the lowest of 5 bidders in the amount of \$222,724.80. The areas to be resurfaced are all in Diamond Lake area; Hickory, Violet, Lilac, Rose and Oak streets and patching will be done on Casey Road.
- Rockland Road Phase 1 Engineering Consulting with engineers from Civiltech and reviewing all information and public comments accumulated over the last 8 months to ensure accuracy. The redacted comments and transcription of the May 23rd meeting will be posted on the Township website in the next few days and announcement of the direction of the project shortly thereafter.
- Casey Road Phase 1 Engineering Working with engineers from Gewalt Hamilton and reviewing information and public comments from the public meeting and also working with the LCDOT on signage improvements. A letter will be forthcoming regarding the status of the project.
