Assessor's Report

Assessor Feeney was not present. Supervisor O'Connor said the office continues to be very busy and the Assessor and staff are handling it very well.

Clerk's Report

Clerk Hansen said Townships are waiting for the Governor's notice of the expiration proclamation which will state the end of the COVID-19 Pandemic. Once the proclamation is announced, Townships can schedule their Annual Town Meeting.

Highway Commissioner's Report

Highway Commissioner Neal said with the dry weather the Road District has made great headway with their road projects.

Trustees' Report

Trustee August complimented the Highway Commissioner and staff for doing a wonderful job.

Supervisor's Report

Libertyville Township has been selected to be a COVID Housing Relief Program (CHRP) Provider. Our initial funding amount will be \$45,000. If the allocation is spent quickly, the Township may be eligible to receive an additional allocation. The funds can be used to provide rental and utility assistance to those residents that qualify. The need must be documented to be COVID-19 related.

APPROVAL TO AWARD 2020 CANTERBURY TREE REMOVAL PROJECT TO CLEAN CUT TREE SERVICES, INC. - \$14,000.00 DISCUSSION & VOTE

Supervisor O'Connor said adjacent homeowners were sent a letter explaining the project. One homeowner was present virtually and thanked the Township for their service. Trustee Nield asked a question about the location of the trees. The Board received a map of the property.

Supervisor O'Connor said the Township negotiated an increase from 10% to 20% for the mitigation credits at the Atkinson Road Property.
