APPROVAL TO PARTICIPATE IN THE TRI-COUNTY ACCESS PROJECT – DISCUSSION AND VOTE:

The Township was invited by the Illinois Tollway Authority and Illinois Department of Transportation to become a participating agency in the Tri-County Access Project. The Federal Highway Administration, in cooperation with the Illinois Tollway and IDOT is initiating an Environmental Impact Statement for the Tri-County Access Project. As a participating agency, the Township would provide feedback in identifying as early as possible any issues of concern regarding the project's potential environmental or socioeconomic impacts that could substantially delay or could prevent an agency from granting a permit or other approval needed for the project. Although Trustee Kovatch was not in attendance, he notified his support of the Township's participation.

A motion by Trustee White and a second by Trustee August to approve the Township's participation in the Tri-County Access Project. Trustee August asked if participation would be an additional cost to the Township. Supervisor O'Connor said there will be no additional cost.
